Dr Jayati Ghosh

Professor, Jawaharlal Nehru University New Delhi

Dr Jayati Ghosh is Professor of Economics at the Centre for Economic Studies and Planning, School of Social Sciences, Jawaharlal Nehru University, New Delhi. Her key areas of research include globalisation, international trade and finance, employment patterns in developing countries, macroeconomic policy and gender & development. Since

2002, Jayati has been serving as the Executive Secretary of International Development Economics Associates (IDEAs) and as the Trustee of the Economic Research Foundation, India (ERF). She has coauthored and edited a dozen books and more than 160 scholarly articles. Her recent books include Demonetisation Decoded: A critique of India's monetary experiment and the Elgar Handbook of Alternative Theories of Economic Development. She has consulted for a large number of international organisations, including ILO, UNDP, UNCTAD, UN-DESA, UNRISD and UN Women. Jayati has been a regular columnist for leading newspapers and journals in India, including Frontline and Businessline. For her eminent contribution, Jayati has been awarded the International Labour Organisation's Decent Work Research Prize for 2010 NordSud Prize for Social Sciences 2010 of the Fondazione Pescarabruzzo, Italy.
